1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in Tender Portal and Gaming Board website.
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the *Gaming Board of Tanzania* during the financial year **2018/2019**. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Proposed Office Fit outs and Interior Works at the 3<sup>rd</sup> Floor of PSPF Dodoma Plaza Located on Plot Number 2 & 4, Block G, NCC Link, Dodoma for the Gaming Board of Tanzania.**
3. The *Gaming Board of Tanzania* now invites sealed Tenders from eligible *national* contractors registered or capable of being registered in *Class V and above* for carrying out the **Proposed Office Fitouts and Interior Works at the 3<sup>rd</sup> Floor of PSPF Dodoma Plaza Located on Plot Number 2 & 4, Block G, NCC Link, Dodoma for the Gaming Board of Tanzania**
4. Tendering will be conducted through the **National Competitive Bidding** procedures specified in the Procurement Regulations, 2013 – Government Notice No.446 and is open to all Tenderers/prequalified tenderers only as defined in the Regulations unless otherwise stated in the Tender Data Sheet/as stated in the Tender Data Sheet.

5. Interested eligible Tenderers/Prequalified tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the Tender Board at *Gaming Board of Tanzania, 27<sup>th</sup> Floor, PSPF Towers, Mission Street, Dar es Salaam, Tanzania, Tanzania* from **09:00 am to 16:00 pm working hours** on Mondays to Fridays inclusive except on public holidays.

A complete set of Tendering Document(s) in *English* and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **TZS 100,000/=** Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **Director General deposited on Account No.012103016135 at National Bank of Commerce, Samora Avenue Branch**
7. All Tenders must be accompanied by a Tender security in an acceptable form in the amount of **2% of Tender Price** or freely convertible currencies in case of foreign Tenderers.

All Tenders in *one original* plus *three* properly filled in, and enclosed in plain envelopes must be delivered to the address at *Secretary to the Tender Board, Gaming Board of Tanzania, 27<sup>th</sup> Floor, PSPF Towers, Mission Street, Dar es Salaam, Tanzania, at* or before **Friday, 10<sup>th</sup> May 2019, at 2:30 pm**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the *Gaming Board of Tanzania, Dar es Salaam*.
9. Late Tenders portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
